

**BYLAW 14-040
OF
LAC LA BICHE COUNTY**

A BYLAW OF LAC LA BICHE COUNTY IN THE PROVINCE OF ALBERTA TO AMEND BYLAW 14-029, BEING THE RECREATION FACILITY FEES, RATES AND CHARGES FOR SERVICES OFFERED WITHIN THE MUNICIPALITY.

WHEREAS the Municipal Government Act, R.S.A. 2000, c. M-26, (herein referred to as "The Act"), as amended, provides that a municipality may pass bylaws for municipal purposes respecting services provided by the municipality;

WHEREAS the Act provides for the establishment of fees for user and facility rental fees by bylaw;

WHEREAS Council has adopted Bylaw 14-029 as the Recreation Facility User and Rental Fees Bylaw;

AND WHEREAS the Council of Lac La Biche County deems it necessary to amend Schedule "A" of Bylaw 14-029 for the purpose of establishing a less expensive walking track fee that remains consistent with other membership and day pass options available;

AND WHEREAS the Council of Lac La Biche County deems it necessary to amend Schedule "A" of Bylaw 14-029 for the purpose of amending the Child Mind fee structures to 30 minute increments;

NOW THEREFORE under the authority and pursuant to the provisions of the said Municipal Act, and by virtue of all other enabling powers, the Council of Lac La Biche County, duly assembled, enacts as follows:

1. That Schedule "A" of Bylaw 14-029 be amended to reflect the additional fees as set out in Schedule "A" of Bylaw 14-040, and that those fees identified in Schedule "A" of Bylaw 14-040 supercedes the walking track and child minding fees set out in Bylaw 14-029.
2. This Bylaw shall come into effect upon the passing of the third reading.
